The Kentucky Board of Licensure for Professional Art Therapists will meet on January 13, 2021 at 1PM by live audio or live video teleconference pursuant to the Kentucky Open Meetings Act, KRS 61.800, *et seq.*, Senate Bill 150, and Executive Order 2020-243 in response to the COVID-19 state of emergency.
